2. Additions to the Agenda*

Chair Harder reports received \$127,000 (approximately) state funding for COVID vaccination clinics of which \$12,000 will be paid out to compensate CHS employees who are charging time for COVID duties. Remainder of money split by percentage, based on population, to three counties: Sibley-20%, Meeker-31% and McLeod-49%.

Kerry Ward, McLeod County Health Educator, tasked with writing Community Health Assessment, gave an overview of process that goes into creating the assessment. Motion by Chair Harder to approve the Community Health Assessment with change to language on page 8 to read: "We understand that we all share the responsibility of creating healthy communities where everyone can thrive. We can only be healthy when the conditions in our communities' support everyone's health." Seconded by Daryl Luthens. Motion carried.

6. Other Agenda Items

a. County Updates (McLeod, Meeker, Sibley)

McLeod: Report given by Amanda Maresh

As of yesterday, at 11am, McLeod County has 3,396 + 58 (probable) =3,454 total COVID-19 cases, with 53 COVID-19 related deaths.

We don't have any schools or congregate care centers listed on the MDH website at this time for cases or exposures.

COVID-19 vaccine dashboard reporting that 6,756 people have received at least one vaccine dose and 3,854 people have completed the COVID-19 vaccine series. This means 18.9% of McLeod's population has received at least 1 COVID-19 vaccine. Per dashboard, 68% of people 65+ have received at least one dose.

At McLeod County Public Health, we've completed 19 COVID-19 vaccine clinics. We're giving the Moderna vaccine. We have another one going on today, planning for 280 doses (65+ and some food processing workers) and a small clinic on Saturday (only about 90 2nd doses).

- Continuing to finish up a few in phase 1A healthcare workers, E-12 and childcare staff. We started more of our 65+ population last week.
- Clinics are going well. We have utilized a few volunteers for clinics. Have started to post
 the link on our website for people to sign up at 9am before we hold a clinic through
 Prepmod. For those that don't have computer access, we are also helping to sign people
 up over the phone. People have been so grateful!
- 1959 first doses given
- 948 second doses given
- 2,907 doses given total McLeod will stop doing CICT as of this Friday, tomorrow 3/12/21. We've received very few essential service requests over the last month.

Meeker: Report given by Diane Winter

Yesterday, at 11am, Meeker had 2,056 confirmed and 36 probable cases, 96 hospitalizations and 21 ICU admissions with 34 deaths. Like most of state, have had a gradual decline with a plateauing of number of cases. 14 day case rate is 7.37%. No LTC breakouts or clusters. Hospital testing and triage line has dramatically decreased. Variant strain cluster present in Carver county, none in Meeker. PH directors are notified directly if a variant strain is identified in their county. Currently focused on vaccination clinics:

 Meeker County: 4,176 1st dose, 2,705 completed series for 18.1% overall rate, 59% of 65+ vaccinated

- Meeker Memorial: 900 1st dose and completing 2nd dose this week
- Family Fare received 200 doses
- Walmart will also be an additional vaccinator
- Public Health: 909 1st dose and 603 2nd doses given. This week administered 200 1st dose. Currently vaccinating age 65+ with extreme effort made to advertise, however; very challenged to locate and schedule this group. Next vaccination group: food processing plant employees.

Sibley: Report given by Rachel Fruhwirth and Klea Rettman

1,1079 positives, 11 deaths, increase in cases and outbreaks in south central attributed to sport exposure. To date Sibley at 1,170 1st dose, no 2nd dose count, Sibley County at 2,691 1st dose and 1,352 complete. 18% of Sibley vaccinated, 57% of 65+ vaccinated. Very successful clinics. Currently vaccinating 65+ and beginning food processing businesses.

b. CHS update

CHS staff prioritizing, supporting and assisting the counties' vaccine clinics. Staff remains at full status. Continuing with CTC as needed. COVID numbers are increasing. B117 Variant present in Carver county; will receive word if present in our counties. FAB has altered their meeting style, due to COVID; however; continue to accomplish duties and make progress. COVID clinics are efficient, uplifting and very much appreciated.
